Health

How do I get access to health services?

Housing

Do I have access to social housing?

Not all Third Country Nationals are eligible for social housing in Malta. Persons having refugee status are entitled to apply to the Maltese Housing Authority program for alternative accommodation known as "Government Units for Rent", provided have been residing in Malta for 12 months and have limited income and assets. Refugees are also entitled to all of the schemes that the Housing Authority offers.

How do I get access to private housing?

Private housing is available in Malta for rent either directly from owners or through estate agents. Some NGOs and Church organisations may also provide assistance or advice on housing. Rental agreements should be signed before any payment is made for rent.

A contract of rent is a private contract under Maltese law which should outline the rights and obligations of both the lessor (the owner of the property) and the lessee (the person renting it). As from 2019 such rental agreements have to be registered by the lessor (owner of the property). It is in your interest to have such a contract in writing.

Problems of working illegally

Working without the relevant license/permit is illegal in Malta and if you do so you will be liable to administrative/criminal penalties. Moreover, working without a license/permit means you do not have the protection which all legally employed persons have automatically. If you work without a license/permit you are much more likely to have your employment rights abused.
